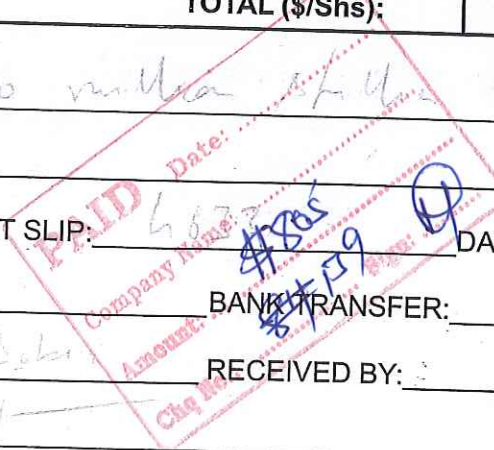

In order for the Ruparelia Foundation to issue the balance payment 70% of your bursary, the following must be complete;

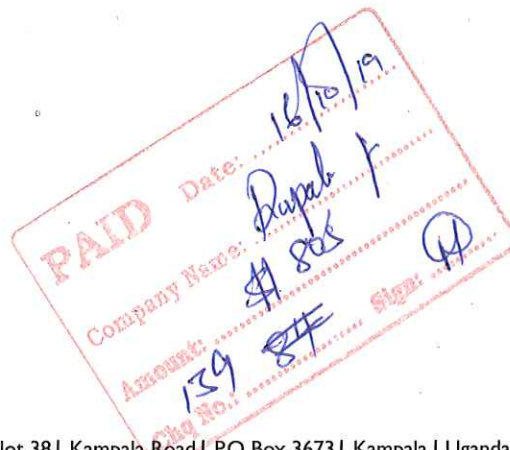




