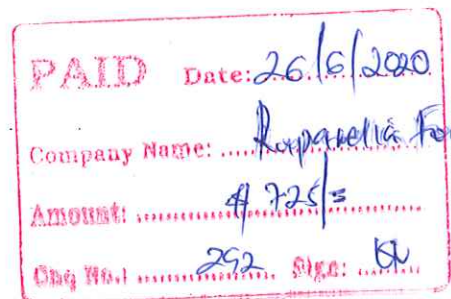

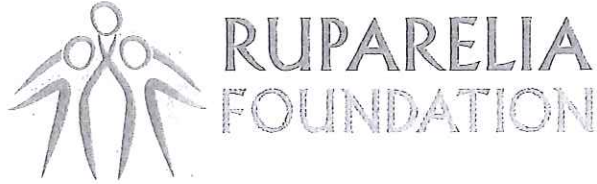

The student must also sign the contract of performance of the scholarship.

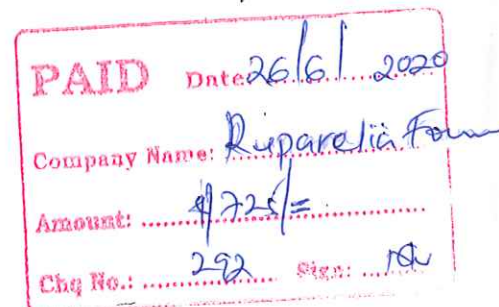
