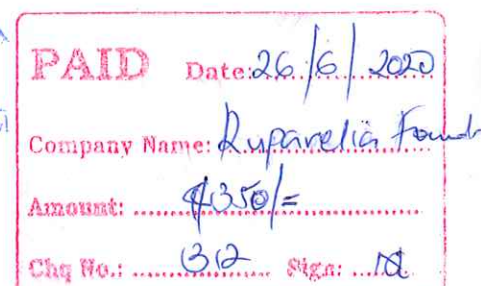

10. The student must also sign the contract of performance of the scholarship (scholarship Application Form).

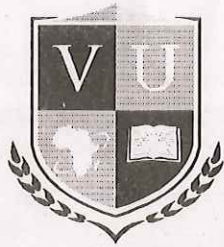
