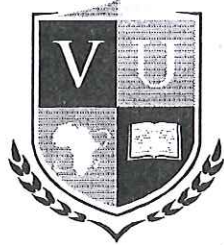

The student must sign off contract of bursary at VU including all terms and conditions of being part of Ruparelia Foundation.

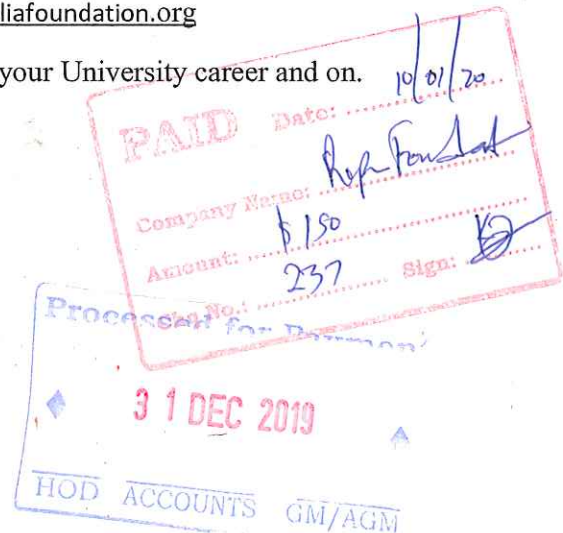
