

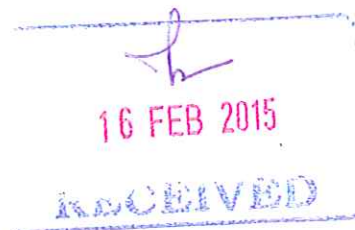
We have now embarked on the construction of the House of God (Church) that's approaching the level of roofing.




