

In July 2014, KCCA in partnership with Uganda Railway demolished a section of Namuwongo slum, leaving many hundreds of families homeless with loss of their small income-producing businesses. Crest Group LTD, under its Property Show Real Estate Social-corporate Responsibility together with Ray of Hope targeted by end of 2014 to relocate 100 families left homeless out of the slum area and into more decent yet low-income rentals within the surrounding communities, giving each family a gift of 3 months' rent, approximately 300,000 Ugx and capital 100,000 Ugx, a total of 400,000 Ugx per family, to relocate into a new home and help re-start and boost their small income-producing business.

Crest Group LTD together with Ray of Hope, an NGO, have partnered for 7 years working within the slum, we profiled 100 families severely affected by this demolition and who desired to move away from the slum life. We reached our initial target by December 23, moving a majority of widows and single mothers HIV positive, and most desperately affected, into low-income rentals they felt able to sustain once the 3 month period was over. Our only directive was they must choose to be relocated out of the slum.

We are happy to announce that every family we moved has successfully remained out of the slum, and continue providing for their families through their small income-producing businesses.

We highly welcome the contribution of USH 2M from Ruparelia Foundation as pledged at the Property Magazine launch on 21st March, 2015 at the Property Expo 2015.
