

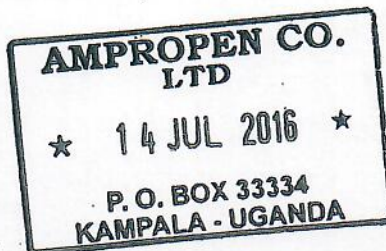

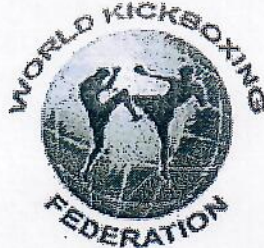

The reasons "Why" we "Postponed" the show are:

- The main event WKF World MMA Champion Jon Leven (Australia) has "still" not been cleared by his Doctor for last year's knee surgery. He should be cleared after July 2016. We support his doctor's advice, and he will be even stronger come 3rd September, 2016.
- The Show Promoter Mr. James White did "Not" get his Event Permit issued by the NSW State Government Sporting Body (Combat Sports Authority -CSA) in time by the 8th May "As programmed Deadline". Still to this day, it has still not been issued. Both these issues above were very significant issues to have us "Postpone" the event again to our new date Saturday 3rd September, 2016 which we are very sure that the event will take place and more fighters are showing interest into the event.


