

We understand that our invitation comes at short notice and may conflict with your busy schedule. Accordingly, if you are not able to attend in person, kindly:

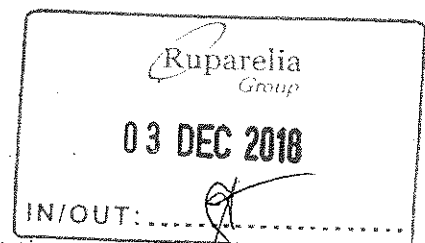
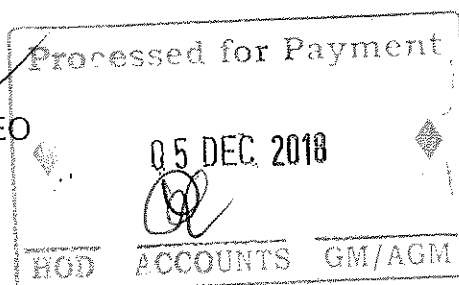

2. Make a generous financial donation to help us meet the expenses of mass mobilization, tents, refreshments and other tokens of appreciation for the participants.

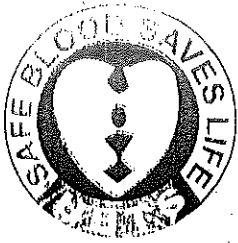

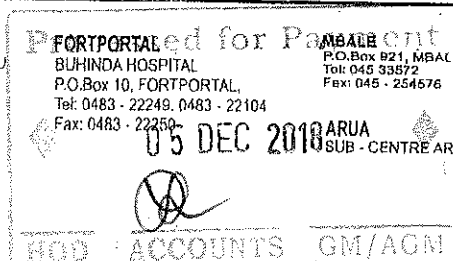

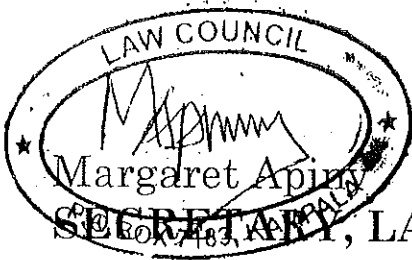
